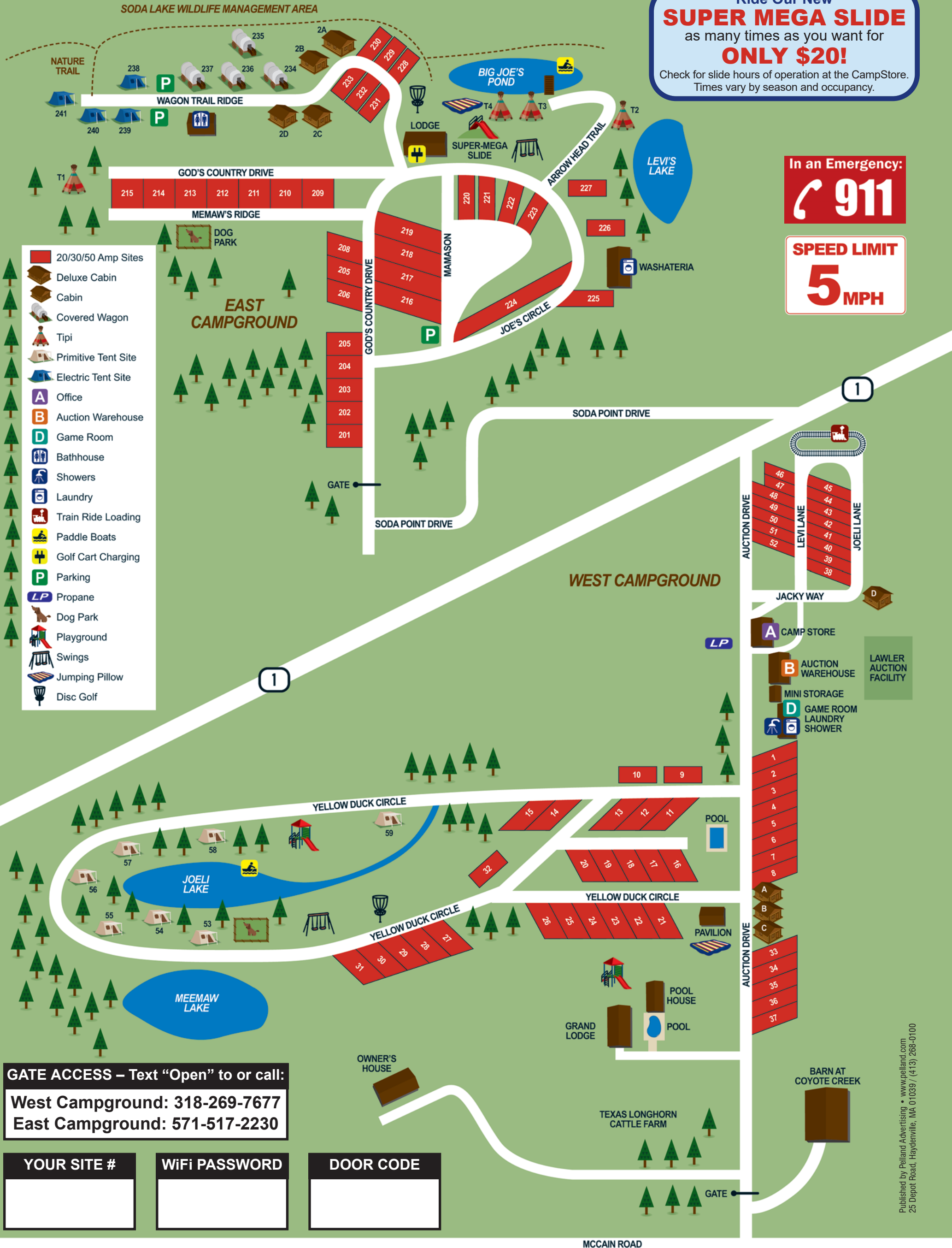

AGREEMENT TO ABIDE BY RULES AND REGULATIONS

As a valued Customer of GOD'S COUNTRY MOUNTAIN VIEW CAMPGROUND, LLC DBA God's Country Resort (further from time to time referred to as "Resort", the undersigned Customer(s) hereby agree to follow all rules and regulations outlined in this written agreement as well as rules which may be posted throughout the campgrounds. Customer hereby agrees to abide by the following rules and regulations.

1. There are no refunds once a reservation is placed or for early check-outs. Customer understands that their site was blocked out for a specific time and that other persons were likely turned away as a result.
2. Customer acknowledges that Campground staff may at anytime request Customer and their guests to vacate the Campground for any reason, and the Customer agrees to vacate the property immediately.
3. No children under the age of 17 allowed in swimming pool area or within 100' of ponds unless supervised by a parent or guardian. Customer assumes all responsibility for their guests, including children, and agrees to be responsible for supervising them around ponds, on playground equipment, swings, slides, jumping pillows, train rides, peddle carts, paddle boats, and all other activities. The roads and driveways are not playgrounds and children should not be allowed to play in the roads or driveways at anytime. No person may enter pool area without designated armbands on.
4. **Swimming Pools are for registered guests staying in an RV site, Cabin, Lodge, Teepee, Conestoga Glamping Wagon, or Tent Site only**, as there is no lifeguard on duty and we are restricted from allowing guests with only a day pass to use our pools.
5. Any child under the age of 17 must be supervised while at the swimming pool by a parent or guardian at all times. **There is No Lifeguard On Duty!** Customer shall bring their own towels and agrees to shower before entering the swimming pool. There shall be no running, diving, or jumping into the pool. Pool hours are 10:00 AM to Dusk each day. The Grand Lodge has it's own private hot tub and pool which is reserved for Grand Lodge guests only.
6. **Jumping Pillows:** Shoes shall be removed before entering any jumping pillow or the crash zone around the pillows. Only bare or socked feet on pillow. No glass containers, cans, toys, or items that could damage the pillow are allowed within the fences surrounding the pillows. No smoking inside fenced area of pillows. Empty pockets of all objects, including phones before entering pillow. Do not enter jumping pillow area before pillow is fully inflated. Do not walk on pillow when it is deflated. Do not jump on pillow when it is raining or wet. Follow instructions of all Staff in the area. No somersaults or inverted maneuvers of any kind while using jumping pillows. Be courteous to others.
7. **The Super Mega Slide** is a new amenity and will have limited hours of operation and height restrictions. Check with CampStore for days and hours of operation, to purchase tickets, etc.
8. **Barrel Train Rides** are seasonal and require a purchased ticket. Check with CampStore for availability and to purchase tickets.
9. The speed limit inside the campgrounds is 5 MPH at all times.
10. **Customer agrees to clean up after themselves** and their minor children after using the public restroom and shower facilities so that the restrooms will be clean for other campers. This is a high class Campground and by staying here, Customer agrees to abide by a higher standard of cleanliness and agrees to do their part to keep the campground, including restroom facilities clean for everyone. Please report any restroom left unclean by a party entering it before your arrival so that staff can address the issue with the previous user. Cameras are located outside the restroom facilities but are obviously not inside the restroom itself.
11. No pets are allowed inside the cabins, Grand Lodge, the wagons, teepees, Community Building, Laundry Rooms, Bath Houses, CampStore, playground areas, jumping pillow area or other locations where marked at anytime. No vicious pets or pets that scare other guests, employees, or owners are allowed anywhere on the Campgrounds. Pets outside an RV must remain on leash at all times. No pets may be left unattended in the dog parks and all owners must pick up and clean up after their own pets at all times. Failure to adhere to this rule will be grounds for immediate expulsion from the Campgrounds and a minimum \$1,500 pet hair abatement assessment charged to the card on file. Customer assumes full liability for all personal injury, death, or property damage caused by their pet(s). Customer agrees to a \$100 pet poop pickup fee if Customer fails to pick up after their animal(s).
12. No Smoking allowed inside or within 20 feet of buildings, cabins, wagons, tipis, bath houses, laundry rooms, CampStore, Game Room, Playgrounds, Slides, Jumping Pillows, or Grand Lodge at anytime. Failure to adhere to this rule will be grounds for immediate expulsion and a minimum \$2,500 smoke abatement assessment being charged to the card on file.
13. No loud music or partying that would disturb other guests. Quiet time is 10:00 PM to 6:00 AM. No cursing, vulgar or indecent behavior will be tolerated at any time.
14. Burning of firewood must be done inside the fire ring or fire pit at all times. No burning during any government issued fire bans. Firewood is available for sale at CampStore.
15. RV sites, tent sites, cabin sites, wagon sites, and teepee sites must remain neat and clean at all times. No outside storage is allowed. Storage lockers are available at the CampStore.
16. Check-Out time is 11:00 AM. Check-In time for cabins, lodges, wagons, and teepees is 4:00 PM. RV site check-in time is 1:00 PM.
17. Trash dumpsters are located just past the CampStore in the West Campground and near the front entrance of the East Campground. Only bagged household trash is permitted, however there is a free Parish maintained dumpster site located at 7329 Highway 1 North, just south of us.
18. There are coin operated laundry facilities at both Campgrounds. Check your map for locations that are open 24 hours a day.
19. There is a 3.5% surcharge for using a credit card or debit card.
20. All persons, including visitors to guests staying onsite must register at the CampStore, sign releases, and purchase armbands from the CampStore located at the West Campground. Only registered guests are allowed in the Campgrounds. All others will be considered trespassing and subject to arrest and prosecution. Armbands are required at all times while utilizing Campground amenities. Some amenities require additional fees. Consult with CampStore for pricing of special armbands.
21. All vehicles must have permit visible at all times and must park in designated parking spots or on their campsite's designated concrete slab. No parking in roads or driveways. Any violators will be subject to a \$50 administration fee that will be charged to the credit card on file for each day of violation. Please respect others and their ability to utilize the campgrounds as well.
22. If Customer wishes to extend their stay, they must check with CampStore for availability. Extensions are not guaranteed.
23. No washing of vehicles or RV's on the property. Failure to comply will result in a \$100 water fee charged to card on file.
24. In the event of freezing temperatures (below 32 degrees) it is the duty of Customer to turn off hydrant and disconnect hose to prevent freeze and breakage of hydrant. Failure to comply that results in breakage will result in a \$350 hydrant replacement fee.
25. No Customer-Owned golf carts allowed on Campgrounds without liability insurance. Proof of insurance must be provided to the office prior to use in the campgrounds. Only licensed drivers are allowed to operate golf carts on the campgrounds.
26. Customers may fish on the Campground ponds, however it is "catch and release" only, so that other campers can enjoy fishing as well. Fishing supplies are available for purchase in the CampStore.
27. Customers staying in the cabins, lodge, or Grand Lodge are required to wash all dishes and utensils prior to checking out.
28. Customer understands that all amenities may not be available at all times, due to weather, maintenance, mechanical issues, etc.
29. Customers who are not employees of the Campground are not allowed to ride ATV's, including side-by-sides while in the Campgrounds due to insurance restrictions.
30. Customers entering the Soda Lake Wildlife Management Area adjacent to the East (God's Country) Campground for hiking, bow hunting, etc., are required to possess a permit that can be downloaded online from the Louisiana Department of Wildlife & Fisheries' website for a small fee. Check-in online is required.
31. Utility trailers, boats, cargo trailers, etc. must be parked in designated locations, which can be rented from the CampStore. They may not be parked at the campsite.
32. Customer agrees to abide by all other rules posted on signage throughout the campground as well as rules provided on the map which is available at the CampStore, which may or may not be included in this agreement.
33. Customer is responsible for all damage caused by themselves, their guests, their children, etc. Special care should be given when staying in wagons, teepees, and while jumping on jumping pillows, as Customer agrees to pay for all damages caused by themselves, their guests, and minors under their care, control, or supervision.
34. Customer assumes all inherent risks for damages caused by lawn equipment throwing rocks, sticks, or other projectiles.
35. **Customer agrees to allow the credit card on file to be charged** for any assessments or fees listed within these rules as well as for any other fees and costs associated with their accommodations at the Campground.
